state of Virginia of the one part and Spratley S. Williams of the County and state
aforesaid of the other party Williford that the said John Moore for and in
consideration of the sum of twenty dollars Current Money to him in hand paid
the receipt whereof is hereby acknowledged has given granted bargained and sold and
by these presents doth give grant bargain and sell unto the said Spratley S. Williams
and his heirs or certain tract or parcel of land lying and being situated
in the said County of Southampton and state of Virginia containing by estimation
four acres in the same more or less and bounded as follows beginning at Maple
corner tree between the said John Moore the said Spratley S. Williams and
Samuel Williford thence westerly course a line of Market tree bearing upon the
said Moore to a sweet gum tree corner tree between the said Williams Elizabeth
McLennan and the said Moore standing in the center of the White Root branch thence
