

This INVENTURE made and entered into this 20<sup>th</sup> day of September in the year of our Lord one thousand eight hundred and forty seven between Charles E Knight of our part and John M Roach of the other part all of the County of Southampton & State of Virginia: Witnesseth that for and in consideration of the sum of three hundred and sixty dollars to him the said Charles E Knight in hand paid by the said John M Roach at or before the making and delivery of these presents the said John M Roach whereby is hereby acknowledged hath granted bargained alienated infugged confirmed and sold unto the said John M Roach his heirs and assigns forever one certain tract or parcel of land lying and being in the County aforesaid containing one hundred and eighty acres or the same more or less lying on the North side of the Chapel Road and bounded by the lands of Scotland Barons Thomas Dawson John M Roach and his heirs of Holliday Derville and together with all the right title claim interest or demand of and in the above described tract or parcel of land and the premises with all and singular its appurtenances thereunto belonging or in any wise appertaining unto him the said John M Roach his heirs and assigns forever to and for the only price now and before of him the said John M Roach his heirs and assigns forever unto the said Charles E Knight for himself his heirs Executors and Administrators doth covenant and agree to and with the said John M Roach his heirs and assigns that he will by these presents warrant and forever defend the right and title of the aforesaid tract or parcel of land and the premises and every part and parcel thereof against the claims of him the said Charles E Knight and every person or persons whatsoever John Wilkins whereof the said Charles E Knight has hereto set his hand and affixed his seal the day and year first above written

This INVENTURE made and entered into on this 18<sup>th</sup> day of September in the year of our Lord eighteen hundred and forty seven between Robert Ellsworth of the County of Southampton and State of Virginia of the one part and Caswell Worrell of the same County and State of the other part witnesseth that the said Robert Ellsworth for and in consideration of the sum of Thirty Dollars Current Money of Virginia to him in hand paid by the said Caswell Worrell at and before the making and delivery of these presents the receipt whereof is hereby acknowledged hath granted bargained and sold unto the said Caswell Worrell his heirs and assigns forever one certain tract or parcel of Land situated lying and being in the aforesaid County of Southampton District of Saint Louis containing by estimation Eight acres or the same more or less bounded as follows beginning at a corner in John M Roach's line then running to the corner of Scott Vick's thence West North west to a corner in Jimmy Worrell's land thence South to the first station 250 feet and so forth the above described tract or parcel of Land and premises and to the said Robert Ellsworth for his heirs Executors and Administrators doth hereby covenant and agree to and with the said Caswell Worrell his heirs Executors and Administrators and assigns that he will by these presents warrant and forever defend all the rights and titles to the aforesaid
