This Indenture made and entered into this 18<sup>th</sup> day of October 1847 between Pittston R. Edwards of the first part, Phadruack Subrell of the second part and Edwards Butte of the third part: Whereas the said Phadruack Subrell, in order to secure the payment of a debt of four hundred and fifty dollars to the said Edwards Butte due by indenture of Trust bearing date the 31<sup>st</sup> day of August 1846 convey to the said P. R. Edwards his heirs Executors or administrators two certain tracts or parcels of Land one containing two hundred and fifty acres more or less and the other tract containing thirty acres more or less which said tracts of Land are more fully described in the deed of Trust aforesaid which was admitted to Record on the 31<sup>st</sup> day of August 1846 upon Trust with power and authority to the said Edwards or in case of his death for his legal Representatives to make sale of the said tracts or parcels of Land in case the said Subrell should make default in the payment of the aforesaid sum of four hundred and fifty dollars and Whereas the said Subrell since the execution of the said deed of Trust has paid to the said Butte the sum of One hundred & sixty dollars in part payment of the debt aforesaid and in satisfaction thereof the said Butte is willing that the aforesaid tract of thirty acres of Land should be released and recovered to the said Subrell Now therefore this Indenture witnesseth that the said Pittston R. Edwards for and in consideration of the promise as well as for the further consideration of the sum of one dollar to him in hand paid by the said Subrell the receipt whereof is hereby acknowledged by the said Pittston R. Edwards with the assent and approbation of the said Edwards Butte signified by his becoming a party to and signing these presents and the said Edwards Butte have granted bargain'd and sold released and confirmed and by these presents do grant bargain and sell release and confirm unto the said Phadruack Subrell all the estate right title interest claim and demand both at Law and in equity which the said P. R. Edwards and Edwards Butte have or hold in the tract of Land hereinafter mentioned containing thirty acres more or less and bounded by the Lands of Benjamin Cott New Robert Edwards L. S. W. Newson Benjamin Deary James H. Hurdin and others to have and to hold the said tract or parcel of Land containing thirty acres more or less unto him the said Phadruack Subrell his heirs and assigns forever to the only proper use and behoof of him the said Phadruack Subrell his heirs and assigns forever and the said Pittston R. Edwards and Edwards Butte for themselves their heirs Executors administrators the above mentioned and described tract or parcel of Land unto the said Phadruack Subrell his heirs and assigns in as full and ample manner as the same was warranted by the said Phadruack Subrell by the deed of Trust aforesaid do warrant the same to the said Phadruack Subrell against the claim or claims of them the said
