Bracke of the County of Southampton & State of Virginia of the one part and Jacob Barnes of the same County and State of the other part witnesseth that the said Emmal Bracke for and in Consideration of the sum of twenty six dollars current money of the Commonwealth to her in hand paid by the said Jacob Barnes at and before the sealing and delivery of these presents the Receipt whereof is hereby acknowledged hath granted Bargained and sold and by these presents doth grant Bargain and sell unto him the said Jacob Barnes his heirs and assigns forever one certain tract or parcel of Land and premises situated lying and being in the aforesaid County of Southampton and parish of Saint Luke Containing ~~one~~ thirty acres (in the same Township aforesaid) and bounded by the Lanes of Josiah Vick Robert Ellsworth James Vick John and Kelly Jackson 30 have and to hold the above described tract or parcel of Land and premises with all and singular its appurtenances there belonging or in any wise appertaining unto him the said Jacob Barnes his heirs and assigns forever to and for the only proper use and behoof of him the said Jacob Barnes his heirs and assigns forever unto the said Emmal Bracke for himself his heirs Executors and Administrators hereby covenant and agree to and with the said Jacob Barnes his heirs Executors and administrators that she will by their present warrant and forever defend all the right and title of the above said tract or parcel of Land and premises and every part or parcel thereof against the claims or demands of all and every other person or persons whatsoever and witnesseth whereof the said Emmal Bracke hath signed set her hand and affixed her seal the day and year first above written
