Beale for and in consideration of the sum of seventy six dollars Current Money of the Commonwealth to her in hand paid by the said Jacob Barnes at and before the sealing and delivery of these presents the Receipt whereof is hereby acknowledged hath granted bargain and sold and by these presents doth grant bargain and sell unto him the said Jacob Barnes his heirs and assigns forever One certain tract or parcel of Land and premises situated lying and being in the aforesaid County of Southampton and parish of Saint Luke's containing together acres (in the said Survey Map) and bounded by the Lands of Josiah Vick Robert Edwards Emma Vick & Co. and Polly Jackson Old have and to hold the above described tract or parcel of Land and premises with all and singular its appurtenances thereto belonging or in any way appur- taining unto him the said Jacob Barnes his heirs and assigns forever to and for the only proper use and behoof of him the said Jacob Barnes his heirs and assigns forever and the said Emma Beale for herself her heirs executors and assigns doth hereby covenant and agree to and with the said Jacob Barnes his heirs executors and assigns that she will by these presents warrant and forever defend all the right and title of the above said tract or parcel of Land and premises and every part or parcel thereof against the claims or demands of all and every other person or persons whatsoever.
