

This Indenture made & entered into on this 17th day of December in the year of our lord
one thousand eight hundred & forty seven between Harrison P Pope & Virginia his wife of
the County of Southampton & State of Virginia of the one part & Samuel Dudley of the same
County & State of the other parts Witnesseth that the said Harrison P Pope & Virginia &
his wife for and in consideration of the sum of Two hundred & fifty dollars Current
Money of Virginia to them in hand paid by the said Samuel Dudley at or before the
making and delivery of these presents the receipt whereof is hereby acknowledged
have granted bargain'd and sold and by these presents do well each of them duly
grant bargain & sell unto him the said Samuel Dudley his heirs & assigns forever
One certain tract or parcel of land and premises situate lying and being in the aforesaid
County of Southampton and parish of St Lukes containing according to some more
or less and bounded as follows to wit: East 5 rods & South by the lands of John
Pope South & west by the lands of Parat Pope 500 hands and to hold the above
described tract or parcel of land and premises with all and singular its appurtenances
thereunto belonging or in any way appertaining unto him the said Samuel Dudley his
heirs and assigns forever he and for the only proper use and behoof of him the said
Samuel Dudley his heirs and assigns forever And the said Harrison Pope and
Virginia & his wife for themselves their heirs & assigns do each of them duly
hereby covenant and agree to and with the said Samuel Dudley his heirs & assigns
covenant and assigns that they will by their private warrant and force defend
all the right & title of the aforesaid tract or parcel of land and premises and every
part or parcel thereof against the claims or demands of all and every other person or persons
whatsoever And Witnesseth that the said Harrison P Pope & Virginia & his wife
have hereunto set their hands and affixed their seals the day and year first above written
