Ferguson and his heirs forever all the estate right title interest property claim or demand whatsoever arises either in law or equity which the said James S. Darden and Catharine E. Darden & Ferguson bounded on the North and East by Josiah Darnell and Saml. and by Miles Cook on the west and on the South and each by Benjamin S. Barrett's Land and by Henry C. Ferguson's Land as the same Containing One hundred and thirty six acres in the same Province together with all and singular the appurtenances to and the several and several rents annuities and remittances yearly and other rents issues and profits thereof and of every part and parcel thereof to have and to hold the said Land with the boundaries hereinabove mentioned and all and singular other the premises herein before mentioned or intended to be bargained and sold and every part and parcel thereof with every of their rights members and appurtenances unto the said Caswell C.
