 administrators and assigns does hereby covenant and agree to and with the said Ichiro D  
 Barnes his heirs and assigns that she the said Mary Barrett and for her heirs the said  
 undivided moiety or part of land with its appurtenances unto him the said Ichiro D Barnes

THIS INVENTIVE makes and entreats into this ninth day of January in the  
 year of our Lord one thousand eight hundred and forty eight between Henry Cook  
 of the first part James Moggott of the second part both of the County of Southampton  
 and State of Virginia and Ichiro D Barnes of the County of Norfolk and State of  
 North Carolina of the third part WITNESSETH that whereas the said Henry Cook  
 is justly indebted to the said Ichiro D Barnes in the sum of three thousand dollars  
 comprised of three separate bonds bearing date the ninth of January eighteen hundred  
 and forty eight and payable as follows: one payable the ninth day of January 1848  
 one payable the ninth day of January 1850 with interest from the ninth day of  
 January 1849 and other payable the ninth day of January 1851 with interest from  
 the ninth day of January 1849 all of which is drawn in favor of the said Ichiro  
 D Barnes as will more fully appear by reference to said bonds which said sum  
 with the interest thereon occurring the said Henry Cook is willing and desirous to  
 draw. Now therefore in Consideration of the premises and for further Consideration  
 of one dollar to him in hand paid by the said James Moggott the receipt whereof is  
 hereby acknowledged the said Henry Cook has granted bargained sold alienated  
 and conveyed and by these presents does grant bargain sell alienate and convey
