the intent of Irvin Griffis (trustee) for and in consideration of the sum of Sixty five dollars to him
in hand paid by the said G. Griffis the receipt whereof is hereby acknowledged have granted
Bargained and sold (at public auction as trustee) unto the said G. Griffis his heirs and assigns
for a certain tract or parcel of Land lying and being in the County aforesaid containing
ten acres more or less and known as the Land which Benjamin H. Griffis conveyed to the said
Irvin Griffis in trust for its benefit of G. Griffis known also as the Land which Robert
Adams did grant to the said Benj. H. Griffis to hold the same granted
Bargained and sold with all and singular the appurtenances thereunto belonging or in any
way appertaining to the same unto the said G. Griffis his heirs and assigns forever and the
said Irvin Griffis for himself his heirs and unto the said G. Griffis his heirs Executors and
Administrators warrant and further defend the right and title to the above named parcel of Land
