This Instrument made and entered into on the 31st day of January in the year of our Lord Eighteen hundred and forty eight between William G. Stephenson of the first part, Thos B. Donell trustee of the second party and Lewis Dorell of the third party all of the County of Southampton and State of Virginia. Whereas the said William G. Stephenson is jointly indebted to the said Lewis Dorell by bond bearing date the 24th day of October 1851 for sum of one thousand dollars and twenty six cents which debt and the legal interest thereon amounting the said William G. Stephenson is willing and desirous to pay now this instrument witnesseth that for and in consideration of the premises and also for the further consideration of one dollar lawful money of the Commonwealth of Virginia to the said William G. Stephenson in hands paid by the said Thos B. Donell trustee at and before the sealing and delivery of these presents the receipt whereof is hereby acknowledged by the said William G. Stephenson he has given granted bargained sold aliened enfeoffed released and confirmed and by these presents doth give grant Bargain sell alien enfeoff release and Confirm to the said Thos B. Donell trustee his heirs and assigns forever the following property to wit two feather beds bed and ticks and furniture one sofa and lamp two tables two chairs two sets of books 1 spider 1 tricke 1 tut 4 pairs two negroes one gun one ax one safe and one hundred pounds bacon To have and to hold the said hereby granted property unto him the said Thos B. Donell trustee his heirs Executors and assigns forever and the said William G. Stephenson for himself his heirs Executors and assigns doth hereby Commande promises and agrees to and with the said Thos B. Donell trustee his heirs Executors and assigns forever to maner and fare following that is to say that the said William G. Stephenson in his Executors and assigns the aforesaid property unto the said Thos B. Donell trustee his heirs Executors and assigns against all persons whatsoever shall and will warrant and force defend by these presents upon Trust, heriot, ship that the said Thos B. Donell trustee his heirs Executors and assigns shall possess
