 consideration of our hundred and sixty two dollars to be in hand paid by William
 Prince Executor of Edward J River decd and friends of Robert Edmund and Robert
 River infants of the said E J River decd of the said County the receipt whereof I
 do hereby acknowledge do by these presents grant bargain sell and convey with the
 said Robert Edmund and Robert River their heirs and assigns a certain piece or
 parcel of Land situated in the said County bounded as follows on the west and
 south by the lands of Isaac H Davis and the lands belonging to the estate of Henry
 Mason decd on the east by the lands of William Prince and the north by the lands of
 Thomas J Perry it was found of the tract of Land which the said Parah River had
 Henry River divide and possess of containing 177 acres together with all
 the privilege and appurtenances to the said Land in any wise appertaining and belonging
 To have and to hold the above granted premises to the said Robert Edmund and
 Robert River their heirs and assigns forever AND I the said Parah River for
 myself my heirs Executors and Administrators do covenant with the said William
 Prince friend of the said infant their heirs and assigns that I and lawfully my heirs
 in fee of the before granted premises that they are free from all encumbrances
 that I have a good and perfect right to sell and convey the same to the said
 Robert Edmund and Robert River their heirs and assigns as aforesaid AND that
 I will and my heirs and my heirs Executors and Administrators shall warrant
 and defend the same to the said Robert Edmund and Robert River their heirs
 and assigns forever against the lawful claims and demands of all persons NOW
 existing whereof I the said Parah River have bought out my hand and
 seal this the 23rd day of March in the year of our Lord eighteen hundred
 and forty eight

 forty eight for the sum of five hundred dollars and Nathl. & Peter for the sum of six
