This Indenture made and executed this 11th day of September A. D. one thousand eight hundred and forty eight between Orrin Holland and Ann his wife of Newmarket Ct. of the first part and Harrison Sinner of Southampton Ct. of the second part Witnesseth that the said Orrin Holland and Ann his wife for and in consideration of the sum of fifty six dollars to them in hand paid by the said Harrison Sinner the receipt whereof is hereby acknowledged bargained and sold and by their personal bargain and sale absolute off and conveyance with the said Harrison Sinner his heirs and assigns forever, not certain tract and parcel of land lying and being in Southampton Ct. near Chick water river on west side of the road from Sams Horse to Franklers Ditch containing by survey forty six and a half acres bounded as follows beginning at @ pine corner of said land in Totten Scoble his thirce hundred by S. Poles line of Mark tree to @ oak corner of Harrison Sinner land thence bounded by the said Harrison Sinner line to the road leading from Sams Horse to Franklers thence @ tree line running up the road to the branch to Chick Landfords land thence up the run of the branch between Chick Landfords and Carr Bowers to @ sweet gum in Totten Scoble his thirce up the said line of S. Poles to the pine at the beginning To have and to hold the above premises with all the revenues and reversions remain in and remaineth yearly and the rents forever, the same Orrin Holland and Ann his wife do hereby warrant and will forever defend the aforesaid premises first forever all the claims or claims demand or demands of all and every person in whatsoever Wherof we have hereunto set our hands and affixed our seal this day and year as before written
