Ferguson and Martha his wife of Guilford County State of North Carolina in their own right and in the right of Collier Ferguson and Sally Ferguson (nee Sally Williams) Richard B. Ferguson and Rebecca D. his wife Joseph C. Ferguson and Margaret his wife Henry D. Ferguson and Albert D. Ferguson of the County of Southampton and State of Virginia all of the one part and Albert D. Ferguson of the said County of Southampton of the other part. Witnesseth that the said Caswell C. Ferguson and Martha his wife Richard B. Ferguson and Rebecca D. his wife Joseph C. Ferguson and Margaret his wife Henry D. Ferguson and Albert D. Ferguson for and in consideration of the sum of one hundred and eighty four dollars
