This Indenture made and entered into this 16th day of Oct in the year of our Lord one thousand eight hundred and forty eight between M^r S Brill of the first part George C Pope of the second part & Harrison P Pope of the third part all of the County of Southampton and State of Virginia. Whereas the said M^r S Brill is justly indebted to the said Harrison P Pope by bond bearing date with the said Harrison P Pope in the sum of one hundred and fifty dollars due the 25th day of December 1849 and not other bond of same date for one hundred and fifty dollars due the 25th day of December 1850 and the said M^r S Brill being willing and desirous to secure the aforesaid debt interest and cost. Now this Indenture Witnesseth that for and in consideration of the premises and for the further consideration of one dollar to him in hand paid the said M^r S Brill by the Sumas at or before the making and delivery of these presents the receipt whereof is hereby acknowledged by the said M^r S Brill hath given granted bargained and sold and by these presents hath given granted bargained and sold to the said George C Pope his heirs and assigns forever a certain tract of Land known as the Parker Brought Land containing three hundred & twenty one M^r & 1/2 and bounded by the Lands of Jacob Barne that known as the Parker Brought Land and to hold to him the said George C Pope proper use and behoof forever upon Trust nevertheless that the said George C Pope shall at the request of either one of the parties aforesaid after giving at least two days notice of the time and place of sale sell at public auction for cash the aforesaid said tract of Land and out of the proceeds first pay the expenses thereof then the aforesaid debt due the said Harrison P Pope and the balance if any pay over to the said M^r S Brill or his legal Representative and the said M^r S Brill Covenant with the said George C Pope that he is possessed of an absolute and simple right in the property hereby conveyed and that he will forever warrant and defend the same against himself and all other persons whatsoever.
