Pope at or before the executing and delivery of these presents (the Receipt whereof is hereby acknowledged) have given and granted and by these presents do give and grant unto the said George C. Pope his Executors administrators and assigns an certain tract or parcel of Land containing one hundred and forty seven acres more or less situated as the former plantation & adjoining the Lands of John Newson General Healt & Harrison D. Pope, do have and hold the said tract of Land unto him the said George C. Pope his Executors administrators and assigns forever and the said Sally Pope for herself her Executors and administrators the said tract or parcel of Land unto the said George C. Pope his Executors administrators and assigns against the claim of him the said Sally Pope his Executors and administrators and against the claim or claim of all and every person or persons whatsoever shall and well warrant and forever defend by these presents "We Witness Through I have hereunto set my hand and seal this thirteenth day of December one thousand eight hundred and forty eight

Pope of the County of Southampton and State of Virginia of the one part and Harrison D. Pope of the same County and State of the other party Witnesseth that the said George C. Pope for and in consideration of the sum of two hundred and fifty dollars to him in hand paid by the said Harrison D. Pope at or before the executing and delivery of these presents the Receipt whereof is hereby acknowledged have granted bargained sold and confirmed and by these presents doth grant bargain sell and confirm unto him the said Harrison D. Pope his heirs and assigns forever one certain tract or parcel of Land situate lying and being in the aforesaid County of Southampton containing one hundred and forty seven acres more or less adjoining the Lands of John Newson General Healt & Harrison D. Pope together with all the right title interest claim or demand of or unto it the above described tract or parcel of Land and premises with its appurtenances thereto belonging or in any way appertaining "do have and hold to have the aforesaid tract or parcel of Land and premises with all and singular its appurtenances thereto belonging unto him the said Harrison D. Pope his heirs and assigns forever to and for the use propriety and behoof of the said Harrison D. Pope his heirs and assigns forever and the said George C. Pope for himself and his Executors and administrators doth hereby covenant and agree to and with the said Harrison D. Pope his heirs Executors and administrators
