This INSTRUMENT made the first day of January in the year of our Lord one
thousand eight hundred & forty nine between Horning J Smith Jr and as the lessee
for Harrison Parker (an infant) and Baldwin Parker set himself of the said park and
John W Gardner of the other party all of the county of Southampton in the State
of Virginia. Witnesseth that the said Horning J Smith as guardian aforesaid
for Harrison Parker for and in consideration of the sum of Two hundred and twenty
dollars to them in hand paid by the said John W Gardner at and before the sealing
and delivery of this present the Recital whereof is hereby acknowledged, by the
said Horning J Smith as guardian aforesaid & Baldwin Parker have granted
bargained and sold and by these presents do and will hold of them back ground
bargain and sell unto the said John W Gardner his heirs and assigns or certain
tents or parcels of Land situate lying and being in the aforesaid County of Southampton
called and known as the Carr "back" end Marker and bounded as follows: Beginning
at a point in the cedar swamp at corner on Dyer Parker road thence west 2.00⁰
66 poles to a post oak about N 76 W 120 poles to a dead pine about S 70 E
40 poles to a white oak about S 52 W 10 poles to the left thence S 46 W 168 poles
to a post oak about S 60 W 154 poles to a point in the gallberry swamp.
S 15 E 76 poles to the Cypress swamp at a point at corner on Elshier's line
before the bridge on the County Road. Thence along the Road leading to Belmont
going the several courses of the road 382 poles to a pine swamp in the
Dunghan's line about N 59 E 82 poles to a point in the cypress swamp thence up
swamp N 58 E 44 poles to a burn then N 38 E 154 poles to a branch of big tree
then out along Horning Gardner's line N 87 E 132 poles to a post oak a corner
about N 76 E 35 poles to a pine then N 57 E 94 poles to a point
in the cedar swamp at corner on John Cott's line then down the Road if same
swamp the several courses thereof 376 poles to the beginning containing just hundred
& forty two acres & no fraction more or less with all and singular the messuages and
inclosures remaining and remaining yearly and other rents & dues aforesaid
and every part and parcel thereof. To have and to hold the said tract or part
of Land with all and singular the premises & appurtenances before mentioned
the said John W Gardner his heirs and assigns forever until the said Horning
Smith and Baldwin Parker for themselves and their heirs the said tract or part
Land with all and singular the premises and appurtenances before mentioned
intendeth to be bargained and sold and every part and parcel thereof unto the
said John W Gardner his heirs and assigns free from all claim or claim of the
said Horning J Smith & Baldwin Parker their heirs and assigns and all
every other person or persons whatsoever shall well and we warrant and
defend by these presents. I W Admire whereof the said Horning J Smith
& Baldwin Parker have hereunto set their hands and sealed the same
