This Indenture made and entered into the 15th day of June year 1847
between John C. Supper of the first part John Barham of the second part and Ben & J.
Harrison P. Pope and B. & H. P. Pope of the third part, all of the County of
Sauhampton and State of Virginia. Whereas the said John C. Supper indebted
to the said Ben & J. Pope by bond bearing date the 10th day of August 1848 in
the sum of five dollars thirty seven and half cents also indebted to the said
Harrison P. Pope by bonds and for fifteen dollars and 37¹⁰⁰ cents dated the 27th
day of Nov^r 1848 and also for seven dollars bearing date with the Indenture
also indebted to the said B. & H. P. Pope by bonds and for forty three dollars
and 37¹⁰⁰ due the 29th Nov^r 1848 and the said John C. Supper having willing
and desiring to secure all the aforesaid debts and Int^s how this Indenture doth
witness that for and in consideration of the premises and for the further consid-
eration of one dollar to him in hand paid by the said John Barham at and
before the sealing and delivery of these presents the Receipt whereof is hereby
acknowledged the said John C. Supper hath given granted bargained and
sold and by these presents doth give grant bargain and sell to the said John
Barham his heirs and assigns forever the following property to wit: all of the
the said John C. Supper present growing crop of corn fifteen acres peas and
potatoes. To have and to hold to him the said John Barham only heirs and
heirs forever upon Trust nevertheless that the said John Barham shall at the
request of either one of the aforesaid parties after giving at least ten days notice
of the time and place of sale sell at public auction for cash all the property
hereby conveyed or so much thereof as shall be sufficient to satisfy said debts and
Int^s and one of the proceeds first pay the expenses thereof then pay the debt
and Int^s of seven dollars and cents dated with the Indenture due Harrison P.
Pope after which pay the debt and Int^s due Ben & J. Pope B. & H. P. Pope
and Harrison P. Pope and the balance if any pay over to the said John C.
Supper or his legal Representatives and the said John C. Supper covenant and
the said John Barham that he is possessor of an absolute fee simple right in
all the property hereby conveyed and that he will for ever warrant and defend
the same against himself and all other persons whatsoever. In Testimony whereof
