between James H. Person of the first part Nathaniel Simmons of the second
part, and Simpson & Rose Mark S. Porter, Edward S. Simmons of the third
part: Whereas the said Nathaniel Simmons by deed bearing date the 29th day of April 1846 and admitted to Record in
the Clerk's Office of Southampton County on the same day in order to
secure the payment of certain debts, therein specified conveyed in deed
to the said James H. Person for that purpose the following property to wit
The Tract of Land on which the said Simmons lived containing 730
acres, also another Tract containing 295 acres: Slaves Anthony, J. J. P.
Pam, Harry, Charlotte and three Children Ben & George four horses two
cows 2 yokes of oxen 10 head of cattle 50 head of hogs 7 head of sheep
all household and kitchen furniture and all plantation and farming utensils
2 Tugs 1 brandy still barrels &c &c &c, crops of all kind including all
the property both real and personal which the said Nathaniel Simmons owned
and whereas since the execution of the said deed the said Creditors
therein named have become willing that the Land and other property above
named should be Released and Redeemed to the said Nathaniel Simmons
Now Therefore This Indenture Witnesseth that the said James
H. Person with the consent and approbation of the said parties of the third
part signified by their signing this Indenture for and in consideration
of the sum of money as for the further consideration of the sum of money
to him in hand paid by the said Nathaniel Simmons, have revised, revised
and forever quit, claim, and by these presents do fully and absolutely
Release, Redeem, and forever quit, claim unto the said Nathaniel Simmons
all the Estate right title interest property claim & demand whatsoever
Law or equity of him the said James H. Person of in and to the above
described Tracts of Land Negroes & other property with all the appurtenances
therein belonging: To have and to hold the above described Lands
Negroes & other property with the appurtenances to the said Lands to
the said Nathaniel Simmons his heirs & assigns to the only proper use and
 behoof of him the said Nathaniel Simmons his heirs and assigns forever
so that the said James H. Person has any other person claiming or to
claim shall by any way or means hereafter have claim challenge or demand
of any estate right title or interest of in or to the above described Tracts of
Land Negroes and other property or any part thereof, but from all and
every estate right title interest or demand of in or to the said above described
Lands Negroes & other property they and every of them shall be utterly excluded
and barred forever by these presents: In Testimony whereof the parties
to these presents have hereunto at their hands and affixed their
