THIS Indenture made and entered into this 12th day of September
 in the year of our Lord one thousand eight hundred & forty three between
 Johnson Barnes & Arat his wife of the first part: Ervin Griffie of the
 second part and Willis Bradshaw of the third part: all of the County
 of Southampton & State of Virginia: Witnesseth: Witnesseth that the
 said Johnson Barnes & Arat his wife for and in consideration of the sum
 of eighty dollars which said sum is due from the said Johnson Barnes
 to the said Willis Bradshaw by bond bearing date August the 18th 1849
 as well as all other monies which may be due and owing from the said
 Johnson Barnes to the said Willis Bradshaw by means of any debts
 transfer of debt or paper whatsoever: as also for and in consideration of
 one dollar to be in hand paid by the said Ervin Griffie the receipt whereof
 is hereby acknowledged: Have granted bargained and sold and by the
 promise duly grant bargained and sold convey and make and unto the
 said Ervin Griffie his heirs and assigns forever one tract or parcel of land
 lying and being in the County aforesaid containing nearly seven acres
 or less and bounded by the lands of the said Ervin Griffie and
 Willis Bradshaw: To have and to hold the above granted and
 bargained premises with all & singular the appurtenances thereto
 belonging unto the said Ervin Griffie his heirs & assigns Int Trust
 forever: and it is hereby declared to be the true intent and meaning
 of these presents that if the said Johnson Barnes shall punctually
 pay to the said Willis Bradshaw his heirs or assigns the said sum of
 eighty dollars with interest as well as all other monies which may be
 due as aforesaid unto the said Willis Bradshaw then the said Ervin
 Griffie his heirs and assigns shall hold the above granted bargained premises
 to the sole proper use of the Johnson Barnes: and the said Ervin Griffie
 covenants & agrees with the parties hereto that if the said Johnson Barnes
 his heirs Executors & assigns shall fail to make payment to the said Willis
 Bradshaw his heirs or assigns, on or before the — all the monies which may
 then be due, then the said Ervin Griffie his heirs & assigns shall stand
 seized of the above granted and bargained premises for the purposes
 following that is to say: that at the request of the said Willis Bradshaw
 his heirs or assigns the said Ervin Griffie his heirs Executors assigns and
 assigns or either of them shall give ten days notice and sell at public
 auction the aforesaid parcel of land and after satisfying all the
 expenses remaining or arising from said notice and sale and all costs
 the same shall pay unto the said Willis Bradshaw his heirs or assigns
 all the money so far forth as shall then be due him and the surplus money
 if any he shall pay over to the said Johnson Barnes his heirs or assigns
 Whosoever of the parties hereto have hereunto set their hands and seals
