This Indenture made and entered into this 10th Jan'y 1850 between Thos S. Sholom and W. W. James Commissioners of the first party; and Ezeiel Jenkins and John B. Jenkins of the second party; Witnesseth that Whereas by a Decree of the Circuit Superior Court of Law and Chancery for the County of Southampton &c pronounced at the November Term 1847 in the suit of Organ vs vs Brychem et al it was among other things directed that Sholom and James as Commissioners should execute unto the purchasers of a tract of land called Poplar Swamp or "Allens quarter" in the proceedings mentioned previously sold by them under a Decree of said Court a proper Deed and Conveyance for the same; and Whereas Ezeiel Jenkins and John B. Jenkins became on the 15th Jan'y 1847 become the purchasers of the same for \$1000 on a credit of one two & three years, and have now fully paid all the purchase money for the same: Now This Indenture Witnesseth that the said T. S. Sholom and W. W. James Comrs as aforesaid in compliance of the premises and of the sum of Ten thousand Dollars in hand paid them by the said Ezeiel & John B. Jenkins at and before the making and delivery of this private bargain sold abovesaid, delivered and conveyed unto they do by this private bargain sell above deliver and convey unto the said Ezeiel Jenkins and John B. Jenkins their heirs and assigns forever, and that tract or parcel of Land situate in the County of Southampton &c called Poplar Swamp or Allens quarter formerly belonging to Wm Allen &c the same that was sold by them as Comrs on the 15th Jan'y 1847 under a Decree of Cir. Ct. of South in suit of Organ vs vs Brychem et al being the whole property embraced in the Indenture that was so directed to them as Comrs by the aforesaid decree of sale at Nov Term 1847. To have and to hold the same with all appurtenances thereto belonging unto them their heirs and assigns forever: And the said T. S. Sholom and W. W. James each for himself and his heirs acting solely as Commissioners under said Decree do hereby convey unto Ezeiel Jenkins and John B. Jenkins their heirs and assigns all the right title & interest which were vested in them as Comrs by the proceedings aforesaid: As Witness the hands & seals of T. S. Sholom and of W. W.
