This Indenture made the 18th day of December in year one thousand
 eight hundred and forty nine between Thomas Drake of the one part and
 Baldy Mountford of the other part, Witnesseth that the said Thomas
 Drake in consideration of two hundred and fifteen Dollars, of lawful
 Money of this Commonwealth to him in hand paid by the said Baldy Mountford
 at or before the making and delivery of these presents, the Receipt whereof
 is hereby acknowledged have bargained and sold and have granted and conveyed
 bargain and sell unto the said Baldy Mountford his heirs and assigns
 a certain tract or parcel of Land containing seventy acres be the same
 more or less bounded as follows to wit: Beginning at a small post or sign
 the Lands of Mathew Williams and lying on Browns Road, from thence line
 between the old Chappell ground and said Land west to a large red oak between
 said Land Mathew Williams and William Jagers road at corner, thence line
 south between said Land and William Jagers to a large spruce pine at corner
 between said Land and William Jagers and Robert Dirlow thence a line
 west between said Land and John Dirlow to a large Red oak at said Browns
 a corner between said Land and John Dirlow and Uriah S. Bracy thence up
 said Road between said Land Uriah S. Bracy to a Cedar bush at corner between
 said Land and Uriah S. Bracy thence west to a Cedar bush between said Land
 and Uriah S. Bracy, thence line Mountford thence North between said Land and
 Amos Mountford to a post oak at corner in Pally Meadows, thence a line
 line of marked trees between said Land and Mathew Williams and to the
 first station together with all the singular houses barns outbuildings
 Gardens orchards Lands Tenements Inclosures pastures and privileges profits
 Commodities advantages emolument hereditaments and appurtenances whatsoever
 to the said Land belonging were any wise appertaining or with the use or enjoyment
 accepted reputed taken or known as part or parcel or member thereof or as
 belonging to the same or any part thereof and the residue a portion and
 outbuildings or remainments of any and other rents issues and profits part and
 every part and parcel thereof to have and to hold the said tract or parcel
 of Land with the Tenements therein before mentioned or intimated to be therein
 and sold and of every part and parcel thereof with every of their right
