

This Indenture made and entered into this 19th day of February 1830 between Albinson T Jones of the first part, Bryant & Vick of the second part, Mills D Sumner & Clarke & Dope of the third part, all of the County of Southampton & State of Virginia; Now Therefore This Indenture witnesseth that whereas the said Albinson T Jones is justly indebted to the said Mills D Sumner in two hundred and twenty dollars with this Indenture for a hundred and seventy five cents, the other bearing date the 1st day of January 1830 for two hundred dollars & fifty cents; and also being justly indebted to the said Clarke & Dope for two hundred dollars & eighty six cents, bearing date with the said Mills D Sumner willing and desirous to deliver the above mentioned debts into the hands of the said Bryant & Vick for the further consideration of one dollar in hand paid to the said Albinson T Jones by the said Bryant & Vick before the sealing and delivering of these presents the Receipt whereof is hereby acknowledged, have granted, bargained & sold and do by these presents do hereby grant bargain and sell to the said Bryant & Vick his heirs Executors administrators assigns, Upson Trust, or Say Mart & Cart; To have and to hold the said Mart & Cart in Trust and upon Conditions Now to wit that the said Bryant & Vick shall at any time hereafter at the request of either the aforesaid parties sell at public auction after giving ten days Notice for each and pay first the expenses which may occur & then pay the debt due the said Sumner & Clarke & Dope, and if the said Mart & Cart should not all for enough to pay the aforesaid debt then in that case the funds to be proportioned in parts; first and if any surplus should remain the said Bryant & Vick is to pay it to the said A. T. Jones or his assigns, and the said Albinson T Jones doth hereby covenant with the said Bryant & Vick that he is possessed of a fee simple right in the property aforesaid that he will forever warrant the same against all persons whatsoever; In Testimony whereof the said parties to these presents have hereunto set their Names and Affixed their seals the day & year first within signed sealed & Delivered
