Rockelle for twenty five dollars and fifty cents due 1st Jan 1849, also one acct due John R. Rockelle for forty seven dollars and fifty cents; and the said William S. Barrett do covenant unto the said John J. Kindred that he will warrant generally the property or money hereby conveyed for the purpose of paying the above named debts and if it is property the said John J. Kindred shall (when the parties above named or a part of them order him to make the money) advertise fifteen days and then sell the property or enough to pay all lawfull expenses about the within named debts, and all of the within named debts for cash but if the said Wm. S. Barrett's part of Davis Bryant dec'd estate should be in money, then the said John J. Kindred shall proceed to collect of the executors or administrators of Davis Bryant dec'd enough to satisfy all of the within named debts together with all lawfull cost in the same, and if the said executors or administrators shall refuse to pay over the money above named, then the said John J. Kindred shall collect the money of them agreeable to Law, and all lawfull expenses shall be paid out of the money recovered. Dick's debt of fifteen dollars due 17th June last, Edward Beaton debt of two hundred and five dollars and twenty six cents due 17th July 1851, by note and acct; one debt due Henry Kindred estate due five Dec. 1850, of the amt of six dollars, one debt due Charles Chamwell's estate of five dollars due 1st October 1851, one debt due Charles S. Brett of one hundred and thirty dollars due by note in 1851, one debt due Lewis R.
