This Indenture, made, rat and entered into this 25th day of December 1851, between John M. Curley of the one part and Thomas S. Drake of the other part. Witnesseth, that the said John M. Curley for and in consideration of the sum of ten dollars to him in hand paid unto him by the said Thomas S. Drake at or before the sealing and delivery of these presents, (the receipt whereof is hereby acknowledged,) Have bargained and sold and by these presents do bargain and sell unto the said Thomas S. Drake his heirs and assigns a certain tract or parcel of land bounded as follows: beginning at a Hickory tree in Nathl. Brenshaw's line, thence east a straight line to a black gum standing in the horse bone branch, thence up said branch to a bay thence a corner for said Thos. S. Drake & James Drake thence along said Drake's line to a small pine a corner in said Brenshaw's line, thence along said line to the beginning: containing by estimation ten acres be the same more or less. The above described land is a part of a tract purchased by me on the 25th day of January last which was sold by virtue of a deed of trust executed by James Drake for the benefit of Thomas Dettlow. To have and to hold the said tract or parcel of land and all the appurtenances thereto belonging unto the said Thomas S. Drake his heirs and assigns forever. And the said John M. Curley for himself and his heirs the said tract or parcel of land unto the said Thomas S. Drake his heirs and assigns free from the claim or claims of all and every person or persons claiming by through or under him shall will and do warrant and defend by these presents all right and title acquired by said purchase and no other.
