Jan 20th 1852.

This Indenture, made this 31st day of January in the year of our Lord one thousand eight hundred and fifty two, between Rich^d & Barrett + Mary R. his wife of the County of Southampton and State of Va. of the one part and Alexander W. Worplest of the other part, Witnesseth that in consideration of the sum of fifty Dollars to them in hand paid, the said Rich^d & Barrett and Mary R. his wife doth grant unto A. W. Worplest a certain lot or parcel of land lying on the north side of Seaboard & R. R. Road in the aforesaid County and village of Franklin Depot commencing first corner in a line with the back part of the aforesaid R. Barrett Store house and at the corner of Seaboard & R. R. Road line and the County road to Jerusalem, thence up the said Road line thirty four yds South 53 degrees West, thence North Seventy yds 33 degrees West, thence North fifty two East thirty five yds thence South Seventy yds 33 degrees East to the first Station.
