Hath granted, bargained, sold and confirmed and by these
presents doth grant, bargain, sell and confirm unto him the
said Geo. B. Dope his heirs and assigns forever, one certain
tract or parcel of land situate, lying and being in the aforesaid
County of Southampton containing three hundred and thirty one acres
be the same more or less adjoining the lands of Mrs. Parkman
