and James Drury of the same County and State of the other part,
Witnesseth, that the said Isaac M. Arnold and Margaret A.
his wife for and in consideration of the sum of Three Thousand five
hundred dollars to them in hand paid by the said James Drury at and
before the sealing and delivery of these presents, the receipt whereof
is hereby acknowledged, do grant, bargain and sell unto him the
said James Drury his heirs and assigns forever all that tract
or parcel of land wherein the said Isaac M. Arnold now
resides situate, lying and being in the aforesaid County of
Southampton and Parish of Saint Lakes containing by estimation
one thousand and seven acres to the same more or less, and
bounded by the lands of Henry Jones, Harrison D. Pope,
William D. Pope, William D. Wolfill, the Heirs of Nathaniel
Francis et al and others, and the said Isaac M. Arnold and Margaret
A. his wife for themselves, their heirs, executors, and administrators
of the sum aforesaid, do hereby covenant and agree to and with

that they will by these presents warrant and forever defend all the
