 the said Jno. J. Kindred doth grant unto the said E. W. Maysenbury
 the following property, to wit: all that tract or parcel of land lying in
 the County of Southampton known as the "Middlebrook" farm, containing
 Nine hundred and twenty nine acres more or less, it being the same farm which
 belonged to Nathan B. Bryant in his life time and bounded by the lands of
 Edward Beaton, Thomas Purdy & others. In trust to secure the payment of
 the following debts, to wit: One bond for seventeen hundred and thirteen
 dollars made payable to James D. Bryant and Robert S. Jones, executors
 of Nathan B. Bryant deceased, dated February 20th and due January
 the 4th A. D. 1855. - On other bond for the like sum of seventeen
 hundred and thirteen dollars due to the same parties bearing the
 same date and on demand the 4th day of January A. D. 1855
 (Both of the above bonds signed by Jno. J. Kindred and Chas.
 B. Kindred.)
