This Deed, made this 20th day of March in the year one thousand eight hundred and fifty four, between Calvert D. Jones, (trustee in a deed of trust made by Benjamin F. Barrett to the same form as trustee for the purpose of securing the payment of a debt to one William Marfee, which deed of trust is dated and recorded at the 15th day of August, A.D. 1853, in the Clerk's office of the County Court of Southampton County) of the one part and James Majett of the other part; That the said Calvert D. Jones by virtue of the deed of trust above mentioned did on the 28th day of January in the year 1854, before the tract of land in the said deed of trust mentioned and conveyed to sale, at public auction, having duly advertised the same (and the said James Majett became the purchaser). Now the said C. D. Jones in consideration of the sum of one thousand seventy dollars to him paid by the said James Majett the receipt of which sum is hereby acknowledged, doth grant and convey to the said Majett in fee simple full that tract of land in the said deed of trust mentioned and described, containing four hundred and forty six acres more or less, and bounded by the lands of Elizabeth Thomas, John D. Myrick and others. It is the intention of the said Jones to convey to the said Majett and his heirs forever a full and perfect title in fee simple to the said tract of land and all its appurtenances so far as he can legally do as trustee, but not in any manner to bind himself personally.
