of Southampton in the State of Virginia of the one part, and Jesse Parker Sen. of the
County and State aforesaid of the other part; Witnesseth; that the said W^m D. Bryant
& Margaret, his wife, for and in consideration of the sum one hundred dollars to them in hand
paid by the said Jesse Parker Sen. they the said W^m D. Bryant & Margaret his wife
have granted, bargained and sold unto the said Jesse Parker Sen. his heirs and assigns, a
certain tract or parcel of land situate, lying and being in the aforesaid County
