and fifty four, between Nathan Turner of the first part, and William H. Griffin
Trustee of the second part, of the county of Wilkes, North Carolina, that the said Nathan Turner do grant
unto the said William H. Griffin, Trustee, the following property, (viz.)
One certain tract or parcel of land containing ninety acres more or
less, adjoining the lands of William H. Griffin, McWilliam H. Griffin, Mary
Turner, and Patsy Griffin &c., one Buggy and Harness, one cart and wheel,
two cows and calves, half Dyons chaise, two chest, two Tables all in
Trust to secure Irvin Griffin security for the said Nathan Turner to about
due Irvin W. Duck to the amount of three hundred dollars bearing
April the twenty fourth eighteen hundred and fifty four - and provided

his wife of the county of Southampton State of Virginia of the one part, and
Alexander W. Napflet of the same County and State of the other part
of the county of Wilkes, North Carolina, that in consideration of the sum of fifty Dollars to them
in hand paid, the said Richard Barrett and Mary R. his wife, doth
grant unto the said A. W. Napflet a certain lot or parcel of
land lying in the aforesaid county and village of Franklin,
commencing on the prolongation of N. E. line of A. W. Napflet
