

This Indenture, made and executed this 28th day of November A.D. One thousand eight hundred and fifty four, between Collint Sticks of the first part, Allen Edwards and Gillian Edwards, Execs of the second part, and Warrant Edwards, trustee of the third part, all of the County of Southampton and State of N.Y. witnesseth; that that the said Collint Sticks is jointly indebted unto the said Allen Edwards and Gillian Edwards Execs as aforesaid in the just and full sum of Two thousand one hundred and Ten Dollars, for the purchase money of the tract and parcel of land whereon the said W.C. Edwards resided at the time of his death containing by Survey Three hundred and forty five acres more or less and bounded by the lands of Jas. W. Murphy, and others, which and appears by note drawing of interest from the date, the principal payable on or before Nov. 28th A.D. One thousand eight hundred and forty four, and the interest payable annually on the 28th Nov. Year thereafter Collint Sticks being desirous to indemnify (and secure the payment of the aforesaid interest as aforesated and the principal on or before it shall be due as aforesaid, and for and in consideration of the sum of one dollar to him in hand paid by the said Warrant Edwards trustee, the receipt whereof is hereby acknowledged, both hereby bargained and sold, confirmed and confirmed unto the said Warrant Edwards, trustee, and his assigns forever the aforesaid tract and parcel of land. Also the following recites viz: Tom, Jerry, George, Jacob, Ann and Lydia aforesaid following of tract, to wit: That if the said Collint Sticks, his exec or adutor, shall fail pay the aforesaid debt when it shall be ent demand or shall fail to pay the interest thereupon annually as beforestated. It shall in such event him legal and right for the aforesaid Warrant Edwards trustee of aforesaid he shall give at least twenty days notice of sale after being required by either of the before mentioned executors to sell at public auction for cash the before mentioned land and negroes or enough thereof to satisfy all the aforesaid debt, interest and costs pay the same and the overplus may over to the aforesaid Collint Sticks his execs or assigns. witness on hands and seals, this day and year as is before written Signed Sealed acknowledged and delivered in the presence of Collint A.
