following and more other that is to say; that the said Joseph W. Holiday Trustee
as aforesaid shall hold the same for the sole and separate use of the said Aunt A.
Joy so long as she shall remain the wife of the said Joseph W. Holiday and shall
allow to each order and direct thereof for her separate use and subject at
any time to the management and disposal thereof as well of the principal funds
as of any issue, profits or interest thereon arising and that the
said Aunt A. Joy may also have power to direct by writing as aforesaid, the
sale of any of the said property and its conversion by investment into other
similar or different funds which thereafter are to be held and used for her separate
as aforesaid, upon the same trust as those to which the property disposed of was
subject. And by the determination of said marriage, by the death of said Joseph
W. Holiday then and thereafter in trust for the sole and exclusive use and bene-
fit of the said Aunt A. Joy as if this indenture had not been made,
and to convey and assign to her, her heirs, executors, administrators and assigns a full
and absolute title to all the trust funds in the trustee's hands; but should the
same happen by the death of the said Aunt A. Joy then and thence after in
trust for such person or persons and their heirs and assigns and for such estates and
on such terms as the said Aunt A. Joy shall have appointed (and declared
by paper writing in the nature and form of a last will and testament
executed in her lifetime by her and in default of such appointment and declaration
in form aforesaid, in trust for the sole use and benefit of the said Joseph W. Holiday
his heirs, executors, administrators and assigns her surviving husband. And
it is further provided that in holding, using, and expending any part of the trust
fund the written order of the said Aunt A. Joy shall be ample authority
to the said trustee and his protection against all claims of all persons for
using, selling, appropriating or employing any part. And the sale of
said property as well as the lands and tenures and other property
therein conveyed as the interest and profit thereof, as the said Aunt A. Joy
shall direct and his receipt the like authority and protection for any
money that may be paid out to her the future trust declared above applying
only to such disposition of the funds as shall be in the said trustee's hands at that
time not having been used or consumed in fulfilling the preceding trust and
carrying out the other provisions of this deed of marriage settlement.
And the said Joseph W. Holiday hereby consents to the foregoing conveyance
and settlement of the estate and property of the said Aunt A. Joy with the trustee
therein created and further more covenants with the said Joseph W. Holiday
to convey and settle upon him as trustee aforesaid whatever property or interest
may hereafter accrue to the said Aunt A. Joy whether by descent, devise, bequest,
or otherwise; whenever required by the said Aunt A. Joy is to convey and
settle the same in such other trustee as she may appoint in like terms
and trusts and limitations as heretofore set forth and to make all other
and further conveyances and assurances of title which the said Aunt A. Joy
may require of him in which may be necessary to give full effect to the
provisions of this Indenture. And the said Joseph W. Holiday in
consideration of his willingness to serve the other parties and in considera-
tion of the promises, all parties to this Indenture covenants with the said
parties and each of them to accept and to now does accept of the
conveyance herein made to him with the declarations of trust attached
and that he will faithfully execute and fulfill the duties and obligations
imposed on him in this deed and that he will make all such dispo-
sitions and conveyances and more other as are consistent with and re-
quired by the trusts of this Indenture. That he will take proper
care of and make due appropriations of all the property here
granted
