This Deed made this 1st day of December in the year one thousand eight hundred and fifty five, between Sarah H. Ford (commonly known by the name of Sarah H. Johnson) of the first part and John H. Rockelle of the other part: Witnesseth; that the said Sarah H. Ford (or Johnson) grants for and in consideration of the sum of five hundred and fifty dollars (\$550.00) to the said grantor paid by the said John H. Rockelle (grantee) the receipt of which sum is hereby acknowledged, hath granted, and conveyed with general warranty to the said grantee all that certain tract or parcel of land situate in the said grantor now resides lying in the County of Southampton (Virginia,) and containing one hundred and forty acres and bounded by the lands of Jacob Barnes on the north, east and south and west the west by William E. Drake's Land, the said Land lies near town, about one mile and a half from the Penny Grove. The said grantor covenants with the said grantee as follows; First; that she hath the right to convey the said Land, that she hath done no act to encumber the said Land, that the said grantee shall have quiet possession of the said Land free from all hindrances or encumbrances, and that the grantor will execute such further documents of the said Land as may be requisite.
