This Indenture made and entered into on the 19 day of January in the year of our Lord Eighteen hundred and fifty six, between William Drake and Annameda Drake his wife of the County of Southampton and State of Virginia of the one part and Joel Vick Junr of the same County and State of the other part. Witnesseth, that the said William Drake and Annameda his wife for and in consideration of the sum of three hundred dollars to them hereof paid by the said Joel Vick at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained and sold unto the said Joel Vick, his heirs and assigns forever, one certain tract or parcel of land situate, lying and being in the aforesaid County of Southampton and parish of Saint Luke's, containing by a recent Survey sixty four acres be the same more or less, situate lot No. 3 in the district of the lands of Josiah Vick dec'd (father of said Annameda Drake) which was recently divided by Commissioners acting under a decree of the Court, and the said lot No. 3 was drawn by said Drake and wife and is bounded as follows: to wit, beginning in the head of John Burgrave's line a corner for lot No. 1 drawn by James Vick, thence along the road No. 86th to 53 poles, thence N 10th 40th 75th poles to the road leading from the Spring grove to the Lypps bridge, thence along said road N. 22th E 15th poles to a corner for lot No. 2 drawn by Elias O. Vick, thence along his line S. 57th E 11 poles to a post, thence N 22th E 9th poles to a post standing in Samuel Vick's line, thence along his line of another tract, a South Easterly course 123th 4 poles to a corner for said John Burgrave's tract, thence along his line to the beginning. To have and to hold the above described tract or parcel of land and premises with all and singular its appurtenances thereto belonging or in any wise appertaining unto him the said Joel Vick his heirs and assigns forever, to and for the only special use and behoof of him the said Joel Vick, his heirs and assigns forever, and the said William Drake and Annameda his wife, for themselves, their heirs, executors and Administrators do hereby covenant and agree to and with the said Joel Vick his heirs, Executors, Administrators and assigns that they will by these presents warrant and forever defend all right and title of the aforesaid lot or tract or parcel of land and premises against the claims or demands of all and every other person or persons whatsoever. In witness whereof, the said William Drake and Annameda Drake have hereunto set their hands and affixed their seals the day and year first above written.
