This Deed made the first day of January 1856 between Patrick Dolan of the one part and George Sperry of the other part, witnesses: that the said Patrick Dolan in pursuance of a decree of Court of Southampton was appointed Special Commissioner to sell a parcel of land belonging to the heirs of Goodwin S. Griffin, after having duly advertised the same, the said George Sperry became the purchaser for the sum of ninety one dollars and 20^{cts}, all of the County of Southampton and State of Virginia. Now the said Patrick Dolan as commissioner doth grant unto the said George Sperry all his right, title and interest to the above named parcel of land, commencing at a pine on the road (and running) north 27 1/2 degrees east 80 poles to a pine and bounded on the Northwest by the lands of Jordan Sperry from said pine South 4 degrees east 62 poles to another pine corner the between William Jenkins and said tract then South 87 degrees west 12 poles to a pine fork and off tree on the said line, then South 77 1/2 degrees west 32 poles to a pine at commencement of Duck Swamp road corner the between William Jenkins and said tract.
