McNeill of the County of Southampton and State of Virginia, of the one part, and John M. Guley of the same County and State of the other part; Witnesseth, that the said Thomas B. McNeill having authority by a deed of trust executed to him by Richard S. Vick, of the said County and State, bearing date on the 21st day of April one thousand eight hundred and fifty three, recorded in the Clerk's Office of the said County of Southampton; in which said Deed of trust, he the said Richard S. Vick did convey to said Thomas B. McNeill in trust, the whole of that tract or parcel of land, to-wit: he the said Richard S. Vick had lately purchased of Joshua Vick, containing two hundred and fifty three acres or about that quantity (be it the same, more or less, it matters not,) and bounded by the land of said Richard S. Vick on the North; on the east by Hottenway river, on the South and west by the lands of said John M. Guley (formerly James Rochelle's) and Henry Blou for the express purpose of securing the payment of a certain debt which he the said Richard S. Vick owed to Joshua Vick and which is described
