This Deed made this 10<sup>th</sup> day of March A. D. one thousand eight hundred and fifty seven between Edward Beaton grantor of the one part, and Alonzo C. Jaynes grantor of the other part witnesseth; that the said grantor for the consideration of the sum of twelve hundred dollars to him in hand paid by the said grantor the receipt whereof which amount is hereby acknowledged have sold and do hereby grant and convey unto the said grantor and to his heirs forever in fee simple that Lot or parcel of Land with the improvements thereon lying and being in the County of Southampton at or near Hogkins Depot bounded as follows: Commencing Eighty three feet from the corner of the Main track of the State road of R. Road thence running forty yards south with the Hogkins Bridge Road on the east side of said road thence forty yards east thence forty yards north, and thence forty yards west to the beginning and all on the west side of the Hogkins Bridge Road and all adjoining the lands of Edward Beaton and the said Edward Beaton grants warrants generally the title of the property hereby conveyed. This Deed made this 10<sup>th</sup> day of May one thousand eight hundred and fifty seven between Spikes Real of the one part and Wm. Hatfield of the other part witnesseth; That in consideration of the sum of one dollar of Law full money of the Commonwealth to the said Spikes Real in hand paid by the said William Hatfield at or before the sealing of this instrument receipt whereof is hereby acknowledged by the said Spikes Real hath granted bargained and sold released and confirmed to the said William Hatfield his heirs and assigns all that tract or parcel of land lying in the County of Southampton and State of Virginia containing fifty two acres to the same more or less and bounded by the lands of Sam Bowes, William Rankin Senr. and Samuel Jaynes heirs. This land was annexed to the said Spikes Real by the said William Hatfield in trust to secure the said Spikes Real as his security to a certain bond due Sam Bowes of the sum of one hundred and seven dollars and forty cents bearing date the 11<sup>th</sup> October 1851 which bond is fully paid off and discharged by the said William Hatfield and the said Spikes Real for himself his heirs and assigns the said tract or parcel of land with all and singular the premises thereunto belonging unto the said William Hatfield his heirs and assigns against the claim of the said Spikes Real or his heirs or assigns.
