

This deed made this 16th day of November 1857 Between James W. Parker of the first part and Geo. W. Peete, Esq., D. Culbert & Walter B. Blunt of the other part, all of the County of Southampton and State of Virginia, that in consideration of the sum of eleven hundred dollars the James W. Parker do grant unto the said Geo. W. Peete, Esq., D. Culbert & Walter B. Blunt all of a certain tract of land lying in the County of Southampton containing about 100 acres and one acre adjoining the lands of Harrison S. Pope, Thos. Ridley Jones and bounded as follows: Beginning at a dead oak standing on Ridley's line, a corner for Harrison S. Pope, thence along his line N 28² E 52 poles to a pine, thence N 30² E 75¹/₄ poles to a corner white oak, thence S 43² E 17 poles to a pine, thence S 48² E 35 poles to a pine thence S 47² E 34 poles to a pine, thence S 48² E 57 poles to a white oak thence S 22 E 71¹/₂ poles to a dead hickory, a corner for Geo. Thos. Ridley thence along his line S 17² W 11 poles to a pine thence S 31² W 16 poles to a pine, thence S 27² W 21 poles to a dead oak, thence S 12² W 12 poles to a white oak thence S 8² W 12 poles to a white oak thence S 53² W 5¹/₄ poles to a pine thence S 77² W 18 poles to a white oak, thence S 44² W 9 poles to a dead thence S 53² W 18 poles to a maple, thence S 60² W 30¹/₄ poles to a pine stump, thence S 63² W 18 poles to a red oak standing near the foot of the hill a new corner in said Thos. Ridley's line, thence along a new line between the said A D 7² W 177 poles to the beginning; and the said James W. Parker warrant generally the property hereby conveyed. This Deed made this 1 day of April 1857 Between Saml. Kelle and Mary the wife of the first part and Sylvanus Hines of the other part, all of the County of Southampton and State of Virginia, Witnesseth that for and in consideration of the sum of Three hundred and forty dollars the said Saml. Kelle and Mary the wife do grant unto the said Sylvanus Hines all their interest in and to a tract of parcel of land lying and being in the County and State aforesaid containing by estimation thirty acres and bounded as follows: Beginning at the corner of Casamea Swamp at a new corner for Levi Duns near 3 chopped Colar poles and an ash thence along a new line of marked trees S 70² E 10 poles to a new corner in Cary's road in Mrs. Rhoda Vick's line, thence along the road and easterly corner 81¹/₄ poles to a corner for said Hines thence along the old original Pierce's line to the end of the Casamea Swamp thence down said Swamp to the beginning.
