said debt and interest. Now this Indenture witnesseth; that for and
in consideration of the premises and for the further consideration of one dollar
to him the said Job Holland rich and fair by the said John Barkham
at and before the sealing and delivery of these presents the receipt
whereof is hereby acknowledged by the said Job Holland hath given and
bargained and sold by these presents doth give, grant, bargained and sold
to the said John Barkham his heirs and assigns forever the following property
to wit: Growing Crop, Corn, oats, Peas, Shucks & Potatoes are sold
Horse one mule one yearling, one Cow & furniture, nine or forty
head hogs ^{and} their fatten increase three beds one furniture, one
folding Table, Six Setting chairs, one Rocking chair three chest
three Trunks, four Dogs, three ovens, one shot gun, one Cart of four
wheels, One bridle & Saddle, one wheel Barrow, five ploughs plow
Hors & Carttins six wood and six grubhors, four carting axes two
sets plow gear, one sett Cart gear, one pair Sad Irons one pair
Ansians Shorel & Tongo, Back mill and Tools all other articles
of Household and Kitchen furniture, also all other farm implements
not herein named. So have now to hold to her the said John Bark
