This Deed made this 9th day of November 1858, between Henry C. Jones of the first part, and Ben^d B. Kinross of the 2^d part, all of the County of Southampton and State of Virginia: Witnesseth; that the Henry C. Jones doth grant unto the Ben^d B. Kinross the following property, to wit; One Bay Horse, One Bay Mare and Gray Filly, all of the household and kitchen furniture, Stock of all kinds, farming implements and crop of all kinds, To secure to secure John R. Peckell in the sum of three hundred dollars due by bond bearing date the 1st day of Nov. 1858, and also to secure Bennett Barnett in the sum of Twenty three dollars due by bond bearing date from Nov. 1st 1858, and also to secure Nathl. Jones in the sum of one hundred and forty dollars due by bond bearing date from the 1st day of Nov. 1858, and also to secure Elijah Rogers in the sum of forty dollars due by account, and James J. Darden in the sum of fifty dollars due by account.

The above obligation is such that if the said Henry C. Jones shall fail to pay when demanded the above named Debts or any one of them - the said Ben^d B. Kinross by the direction of any one of the parties, shall after giving legal notice, sell for cash the abovesaid property, and with the proceeds thereof pay & discharge said Debts and the pay, if any, pay to the said Henry C.
