Pope his wife of the one part and Giles Pope of the other part, of the County of Southampton, that in consideration of the sum of Two hundred and seventy dollars the said Pope and his wife do grant unto the said Giles Pope a parcel of Land containing by the survey six acres be the same more or less known as a portion of the old Billings Chapel tract and formerly owned by Mrs. Eliza Cretchley in the County of Southampton and adjoining the lands of the said George C. Pope, Giles Pope, Amos S. Pope, others together with all the privileges and appurtenances thereto belonging and the said Pope and his wife do covenant with the said Giles Pope that they are seized in fee of the above granted premises that they have a right to sell and convey the same; and that they will warrant and defend the right and title the right and title thereof to the said Giles Pope and his heirs against the lawful claims of all persons.
