Witnesseth that the said party of the first part for and in consideration of the sum of five hundred and fifty dollars and fifty cents law full money of Virginia to him duly paid and lawful the delivery hereof each bargained and sold and by these presents doth grant and convey to the said party of the second part his heirs and assigns forever all that certain piece or parcel of land lying and being in the County of Southampton and State of Virginia and which is known and described as follows to wit: bounded by the lands of John McWhorter, Anthony Harris and the estate of Peter Edwards, containing one hundred and eighty three and a half acres more or less together with all and singular the tenements and appurtenances and all the estate, title and interest of the said party of the first part therein and the said party of the first part doth hereby convey and agree with the said party of the second part that after some of the aforesaid being the said part of the first part is the lawful owner of the premises above granted and conveyed thereof in fee simple absolute and that he will warrant and defend the above granted premises in the quiet and peaceable possession of the said party of the second part his heirs and assigns forever.
