Holloway and Crummita his wife for ourselves, ourselves Executors, Admors &c do warrant and defend the said Interest unto the said Robert Pritlow and his heirs against the claim or claims of all and every person whatsoever. Johnson, Peter J. Holmes, said Robert Pritlow, Gellings Ward and others. And she the said Georgianna Bailey doth warrant and defend unto the said Robert Pritlow the property hereby conveyed.
