Cland and Mary A. his wife, for themselves their heirs, executors, and admrs. do hereby covenant and agree to and with the said James Draw his heirs, executors, and admrs. and assigns that they will by these presents warrant & forever defend all the right and title of the aforesaid tract or parcel of land and its appurtenances against the claims or demands of all and every other person or persons whatsoever.
