This Indenture made the sixteenth day of June in the year of our Lord Christ one
thousand seven hundred & sixty between Thomas Draper of Southampton County of the one part
and Joseph Denson Benjamin Denson James Jordan Scott Robert Ricks & William Jones & the
Society of people called Quakers and their heirs of the other part Witnesseth that the said Thomas
Draper for and in consideration of the sum of five Shillings current Money of Virginia to
the said Thomas Draper in Hand Paid by the said Joseph Denson Benjamin Denson James
Jordan Scott Robert Ricks & William Jones and Society at or before the inscaling and Deliv-
ing of these presents the receipt whereof the said Thomas Draper doth hereby acknowledge & thereof
Agree the said Joseph Denson Benjamin Denson James Jordan Scott Robert Ricks & William
Jones Society and each of them hath Granted bargained and Sold Aliened enfeoffed & confirmed
and by these presents doth Grant bargain and sell alien enfeoff and confirm unto the said
Joseph Denson Benjamin Denson James Jordan Scott Robert Ricks & William Jones and
unto the said society of People called Quakers & their heirs & assigns forever all that Tract or parcel
of Land situate Lying and being in the aforesaid County Southampton on the South side of Black
Cuck Swamp containing Two Acres of Land more or less and bounded as follows to wit beginning
at a pine on a small Branch on the South side of the New Providence near South to a Turkey
Cuck & thence South East to a Turkey Cuck & thence North to a Red Cuck & thence to the pine begun
at near the said Thomas Draper which said two Acres of Land together with all houses Patches
Gardens Orchards Improvements Woods & Under Woods Water & Water Courses with all appurten-
ances thereto belonging or in any wise pertaining To have and Hold the said premises together
with all appurtenances to them the said Joseph Denson Benjamin Denson James Jordan Scott
Robert Ricks & William Jones and the society their heirs and assigns for ever and the said Thomas
Draper do hereby agree with the said Joseph Denson Benjamin Denson James Jordan Scott
Robert Ricks & William Jones and the society that at the Delivering of these presents there
be a sufficient written title to the said premises & have Lawful Title to dispose of the same
