Beginning at a gum on the North side of the Doctors Beach a Corner of Roger Woodards thence by the Courses of the Patent to Lightwood Post a Corner of Tho^s Greenshaw by the s^d Greenshaw line to another Lightwood Post a Corner of Jo^s West West Land & by the s^d West line to a Pine on the side of the Doctors Branch & up the various Courses of the s^d Branch to the Beginning with all Trees Woods underwoods Commons & Common Pastures Profits Commodities Advantages Emoluments hereditaments whatsoever to the Tract of Land belonging or in any way appertaining upon the same or arising also the Reversion & reversions Remainders & remainders Rents Services of the Premises & every Part thereof all Rights Title Interest Claims & Demands whatsoever of him the s^d Jo^s Cobb or to the same Premises & every Part thereof To have & to hold all & singular the s^d Premises above mentioned & every Part & Parcell thereof within the appurtenances unto the s^d Rob^t Daughtry & his Heirs to the only Proper Uses & behoof of the s^d Rob^t Daughtry & his Heirs forever the s^d Jo^s Cobb for himself his Heirs the s^d Land & Premises & every Part thereof against him & his Heirs & ag^t all & every other Person or Persons whatsoever that the s^d Jo^s Cobb his Heirs & assigns shall & will warrant & serve & defend by these Presents In Witness whereof the s^d Jo^s Cobb hath hereunto set their Hands & affixed their Seals the Day & Year above Written ~
