This Indenture made the first Day of July In the first year of the Reign of our Sovereign Lord George the third now King of Great Britain &c And in the year of our Lord Christ one thousand seven hundred & sixty one Between Joseph Mounger of the Parish of Nottoway & Co^{ty} of Southampton Planter of the one Part & Richard Kello of the Parish & Co^{ty} of a^s Gent of the other Part Witnesseth that the said Joseph Mounger for in Consideration of the sum of three Pounds seven Shilling Current Money of Virginia to him in hand Paid by the said Richard Kello the Receipt whereof the said Joseph Mounger doth hereby acknowledge & thereof Acquitt & Discharge the said Rich^d Kello his heirs Exors & admors by these Presents Hath granted Bargained Sold Aliened Inscossed & Confirmed by these Presents Doth Grant Bargain sell alien Inscossy Confirm unto the said Richard Kello & to his Heirs & assigns forever all that Tract or Parcel of Land Situate lying & being in the Parish & County a^s on the south side of Seacock Swamp Containing twenty five Acres & bounded according to the most Antient & reputed Bounds which said Tract or Parcel of Land is Part of a Patent formerly granted Joseph Exum by Patent bearing Date the 17th of July by the said Joseph Exum Sold & Conveyed to one Robert M. Mounger Deed Father of the said Joseph Party thereto & by the Death of the said Robert is descended & Come to the said Joseph Mounger as his Son & heir at Law And all houses out houses Edifices Buildings Yards Gardens Orchards Trees Ways Waters Water Courses Profits Commodities Hereditaments & Appurtenances to the said Plantation Tract or Parcel of Land belonging in any wise Appertaining & the Reversion and Reversions Remainder & Remainders Rents Issues & Profits thereof and every Part and Parcel thereof And all the Estate right Title Interest Possession
