This Indenture made the 11th Day of June in the first Year of the Reign of our Sovereign Lord George the Third by the Grace of God of Great Britain France & Ireland King Defender of the Faith &c and in the year of our Lord God one thousand seven Hundred & sixty one Between John Hinds of the County of Southampton & Parish of Vottonway of the one Part & John Hinds Jun. of the aforesaid Parish of the other Part Witnesseth that the s^d John Hinds for divers good causes & Considerations but more especially for in Consideration of the Sum of five Shillings Currant Money by the s^d John Hinds Jun. to him in hand Paid the Receipt whereof is hereby Acknowledged he the s^d John Hinds hath given granted Bargained Sold Alien'd & Confirmed and by these Presents Doth give grant Bargain Sell alien & Confirm unto the s^d John Hinds Jun. and to his Heirs & assigns the Plantation whereon the s^d John Hinds Jun. now liveth together with one Hundred Acres of Land be the same more or less & bounded as followeth / To wit / Beginning at a Black Oak by the main Road then running along a line of Mark^d Trees to a black Oak in Richard Parkers line then along Parkers line to the Pine Mark^d a Corner of W^m Simmons Land then along Simmons line to the Road aforesaid then along the Road to the Beginning & also all Trees Woods Underwoods Profits Commodities advantages & Creditments ways waters & Appurtenances whatsoever the s^d Piece or Parcel of Land hereby Bargained and Sold or intended to be hereby Bargained & Sold Belonging or in any Wise Appurtenanting and also the Reversion & Reversions Remainder & Remainders Rents Issues & Profits of the s^d Premises & every Part thereof and all the Estate Right Title Interest Claim & Demand whatsoever of him the s^d John Hinds of in and to the s^d Piece or Parcel of Land hereby Bargained and Sold or intended to be hereby Bargained & Sold and hereby To have and to hold the s^d Piece or Parcel of Land hereby Bargained & Sold or intended to be hereby Bargained & Sold of all & Singular the s^d Premises above mentioned & every part and Parcel thereof with the Appurtenances unto the s^d John Hinds Jun. his Heirs & assigns To the only proper Use & behoof of the s^d John Hinds Jun. his Heirs & assigns forever the s^d John Hinds for himself and his Heirs the s^d Piece or Parcel of Land hereby Bargained and Sold or meant Mentioned or intended to be hereby Bargained & Sold & Premises & every Part thereof agst him & his Heirs & all every Person & Persons Whatsoever to the s^d John Hinds Jun. his Heirs & assigns shall & will warrant & forever Defend by these Presents In Witness whereof the s^d John Hinds hath hereunto set his hand & affixed his Seal the Day & Year first above Written
