This Indenture made this Eleventh Day of June in the Year of our Lord One thousand seven hundred and Sixty One Between Joshua Vick of Virginia's County of Southampton of the one Part and Nathan Vasper of the same County of Colony aforesaid of the other Part Witnesseth that the said Joshua Vick for & in consideration of the Sum of Ten Pounds Ten Shillings Current Money to him in hand paid by the said Nathan Vasper the Receipt whereof the said Joshua Vick doth hereby acknowledge he the said Joshua Vick hath Granted Bargained and Sold Alien'd & Confirmed & by these Presents doth grant bargain & Sell Alien'd & Confirm unto the said Nathan Vasper his Heirs & assigns forever all that Plantation Tract or Parcel of Land situate lying & being on the South side of Nottoway River Containing by Estimation one hundred and Twenty five Acres & bounded as Followeth: To Wit Beginning at a Cypress standing on the side of Nottoway River Formerly a Corner Tree of John Vaspers Mentioned in a Patent granted to Richard Vick Bearing date the twelfth day of February One thousand seven hundred & Forty two then Running on the said Patent line to Vicks Branch then Running down various Courses of the said Branch to the said Patent line then Running on the several Courses of the said Patent line to the Beginning thereof One Hundred & Twenty five Acres of Land being Part of a Patent granted to Richard Vick bearing date as above Together with all Houses & Buildings therein with the Reversion & Reversions Remainder & Remainders Rents & Issues and Profits thereof and every Part and Parcel thereof with the Appurtenances To have And to hold the said Tract or Parcel of Land and also Singular the Premises above Mentioned and every Part & Parcel thereof unto the said Nathan Vasper to the only proper Use & behoof of the said Nathan Vasper his Heirs & assigns forever & the said Joshua Vick for himself his Heirs & assigns & Admin^r the said Messuage or Tenement and Premises & every Part thereof against him & his Heirs and against all and every
